REGISTRATION

All competitors, referees, coaches and officials must register online using the online system on *http://www.sportdata.org/karate1*. In case of any questions concerning the online registration please directly contact the sportdata software team via the email address *office@sportdata.org*.

Clubs / teams / federations are responsible for the quality of the entered registration data. Changes of online registration data are possible until [Date of the official registration session].

The official registration session will take place on **[Date of the registration day – one day before the event starts]** from 10.00 a.m. to 8.00 p.m.

If changes are required during the official registration session because of incorrect, missing or new registration data, a fee of € 15 is charged for each change.

At registration, accreditation cards will be issued bearing the participants main data, a photograph and information about registered categories. The accreditation card must be carried at all times during the event.

Participants are only admitted with valid WKF ID card. Validity of WKF ID cards will be verified during the registration session.

The WKF ID card can be purchased at the registration session.

Afghanistan: Ordinary and official passport holders are required to have visa to enter Turkey.

Albania: Ordinary passport holders are required to have visa to enter Turkey. They can obtain two-month multiple entry visas at the Turkish border gates. Official passport holders are exempt from visa for their travels up to 90 days.

Algeria: Ordinary passport holders are required to have visa to enter Turkey. Official passport holders are exempt from visa for their travels up to 90 days.

Andorra: Ordinary and official passport holders are exempt from visa for their travels up to 90 days. Angola: Ordinary and official passport holders are required to have visa to enter Turkey.

Antigua-Barbuda: Ordinary and official passport holders are required to have visa to enter Turkey. Ordinary passport holders can obtain three month-multiple entry visas at the Turkish borders gates.

Argentina: Ordinary and official passport holders are exempt from visa for their travels up to 90 days.

Armenia: Ordinary and official passport holders are required to have visa to enter Turkey. Ordinary passport holders can obtain one-month multiple entry visas at the Turkish border gates.

Australia: Ordinary and official passport holders are required to have visa to enter Turkey. Ordinary passport holders can obtain three month-multiple entry visas at the Turkish border gates.

Austria: Ordinary passport holders are required to have visa to enter Turkey. They can obtain three monthmultiple entry

visas at the Turkish border gates. Official passport holders are exempt from visa for their travels up to 90 days.

Azerbaijan: Ordinary passport holders are required to have visa to enter Turkey. They can obtain one monthmultiple entry visas at the Turkish border gates. Official passport holders are exempt from visa for their travels up to 90 days.

Bahamas: Ordinary passport holders are required to have visa to enter Turkey. They can obtain three month multiple entry

visas at the Turkish borders gates. Official passport holders are exempt from visa for their travels up to 90 days. Bahrain: Ordinary and official passport holders are required to have visa to enter Turkey.

Bangladesh: Ordinary passport holders are required to have visa to enter Turkey. Official passport holders are exempted
